

Hello Renee, et al,

I am glad to finally have contact information for Mr. Allen's counsel. Should you be CC'ed on any legal correspondence? Also, is the contact information in your signature sufficient for contact via my counsel?

Although I probably shouldn't do this, I am going to respond to this email directly so that we can move things along a bit faster. Also, I would like you to understand how you are now perpetuating a long history of harrasment, and exposing your firm to litigation at the same time. First off, I have never made any non-truthful statements regarding James. If the facts paint your client in a negative view, that is because of how he has chosen to live his life, and is essentially not my problem.

Mr. Allen took to the internet many false claims as early as 2002. Since that time, I have been publicly accused of international kidnapping, sexual abuse, gang affiliations, and many other, as you put them, "false, misleading, and defamatory statements," by your client. I have evidence in the form of website archives, statements that Mr. Allen has made on social networking sites and direct statements that have been made to others. As for the demands in your letter, there is no campaign to injure Mr. Allen. In fact, it's quite ironic that you should bring up this subject as it is the wild statements made by your client which have yielded trouble for those of us on the receiving end of his defamation. Although the record has always been remedied with the appropriate parties, I have been questioned regarding his statements before offers of employment were extended on two occasions. The stigma from the statements Mr. Allen made did not have a lasting effect, but they did cause interference regarding eligibility for employment.

Further dissecting your claims, you allege that I have delivered untruthful statements about James' mental health, former employment, relationship with his child and military service. Everything that I have spoken to has been factual, and continues to remain that way. I'm qualified to speak regarding the relationship with his child because I financially supported Magnus for almost the first 5 years of his life, and continue to visit with him regularly. I can deliver factual and direct testimony in regards Mr. Allen's abandonment, as I was negatively impacted, albeit voluntarily, and injured by his actions.

When it comes to former employment and military service, I know people that worked in the same organization as James at Nortel, and a former Tek Systems account representative. I also know individuals that have worked with him at Terrabox (sp) and through his company, Shadowdancers *, and its many affiliates. Take notice that my statements are not just opinion, and do contain factual basis. As for his military service, I have received information available under the FOIA, which was initiated due to false claims by your client regarding his military service. As such, my written accounts are factual. They remain vague because I am unsure of the legality on directly publishing this information. I've sought the assistance of the POW Network (an organization that aims to expose military phonies and embellishers) to find out what is legal to publish, and what is not.

James has sought to injure me via false statements which he cannot support, dating back to 2002, and possibly before that. These statements prompted me to generate a website in 2004/2005, so that I could directly respond to Mr. Allen's false accusations; however, I lost interest and did not feel he was worth my energy. Early this year his defamatory statements became more and more abrasive, and I once again sought an avenue to respond to his rhetoric. Reference the following most-recent false claim made to my Internet Provider in a written communication by Mr. Allen,

"We have logged these attacks in detail and are making a report to the FBI, as this follows on in a criminal investigation so reported to Federal Authorities today. Please retain user access logs and account information, and monitor your network for abuse sent to [REDACTED] - as this may relate to a Federal crime against witnesses across State lines in a kidnapping case"

I actually provide consulting services to this client, and I have recorded the IP Address information and website logs which detail the generation of this communication by Mr. Allen, which has been archived in the trove of content he has published over the years.

What is interesting here is that Mr. Allen attests that I have harassed a witness, and was a party to some form of kidnapping. This is knowingly false as per, <http://courts.dallascounty.org/CaseDetail.aspx?CaseID=2410239> . As far as harassing a witness in an ongoing case goes, there is no case, hence no witness. These allegations continue Mr. Allen's trend of wreck less statements regarding others. In summary, I have been discussed in great detail by your client who has attributed me via written statements to gang affiliations, being sexually abusive, trafficking narcotics, associating with several individuals that I don't even know exist, auto-theft, assault and possibly even more statements that I'm just not aware of.

As a direct result of Mr. Allen's actions, this website exists, and will remain operational until such a time that your client retracts his non-truthful statements regarding me, on every website that he has ever used in his slanderous rants. I have been so busy that I have not recently updated jamesarnoldallen.me, and almost even forgot that it existed; however, your recent communication has prompted me to apply more attention towards this medium.
