For those of you already reading the above thread, you are currently involved in a libel instance and should be aware that this reply constitutes the 'other side of the story' that you are not being told. Repeated requests to cease this slander and avoid further criminal actions have been ignored, so I am providing this response after much abuse.

To my knowledge, I am UNAWARE that my child is in the HOSPITAL. Things like this being kept from me are the very reason this has gone to court. The expenses of the hospital costs were 100% paid last year to my knowledge - and if new expenses have been incurred no effort to inform me has taken place. The court order says exactly that.
